

Memorandum of Understanding

between

ESCP - European Society of Clinical Pharmacy

and

SIFaCT – Società Italiana di Farmacia Clinica e Terapia

I. Background

On the basis of written communication, the European Society of Clinical Pharmacy (ESCP) and Società Italiana di Farmacia Clinica e Terapia (Italian Society of Clinical Pharmacy and Therapeutics, SIFaCT) affirmed their will to increase collaborative relationships in order to strengthen practice, education and advocacy of science. Moreover, they agreed to develop a Memorandum of understanding (MoU) that will set the framework under which they may broaden and intensify joint activities.

II. Information about ESCP

The European Society of Clinical Pharmacy (ESCP) is an international association foundedin 1979 by clinical practitioners, researchers and educators from several European countries.

The overall mission of the society is to promote, support, implement and advance education, practice and research in clinical pharmacy in order to optimize outcomes for patients. Specifically, the society promotes the value and impact of clinical pharmacy services among health care professionals, scientific societies, health authorities and the public; and raises awareness of clinical pharmacy practice and its activities.

Individual members include clinical pharmacists, hospital pharmacists, community pharmacists, researchers and educators from over 50 countries. Pharmacists, pharmacy technicians, pharmacy students or other healthcare professionals working in the community, hospital, academic setting, industry or anyother healthcare setting in any country are eligible to become members of ESCP.



The society is governed by a General Committee and supported by committees relating to Research, Education, Communication and Special Interests. There are two key annual events, a major symposium in October and a workshop earlier in the year. There are also several practice, research and education webinars and other key clinical pharmacy related products.

III. Information about National Clinical Society

The Società Italiana di Farmacia Clinica e Terapia (Italian Society of Clinical Pharmacy and Therapeutics, SIFaCT) is a society of specialized pharmacists practicing in the NHS, founded in 2012.

The overall mission of the society is to promote, support and implement education, practice and research in clinical pharmacy in order to optimize outcomes for patients. The final goal is to spread clinical pharmacy in all hospital and ambulatory practices in the Italian NHS, with pharmacists actively involved in multidisciplinary teams, actively practicing clinical pharmacy and documenting their activity within the health care team.

Individual members include pharmacists with a specialization degree, practicing in the Italian NHS, and graduate students (e.g., residents in hospital pharmacy or pharmacology). Community pharmacists and pharmacy technicians may become "aggregate members".



The society is governed by a General Committee and supported by a Scientific Committee. The Society employs a Scientific Coordinator, in charge of coordinating educational and research activities.

To date, the society accounts professional networks in two clinical pharmacy areas: oncology and infectious diseases, with the plan of gradually implementing more in different therapeutic areas.

There are three key annual events: the national congress in Autumn, and two symposia related to each professional network. Several other educational events, mainly in collaboration with physician professional societies (e.g., webinars, masterclasses in clinical pharmacy, educational courses) are planned each year.

The society is the sponsor of several multicenter real-world studies run by members as principal investigators.

The benefits of SIFaCT membership are as follows
